Upon authorization, your Yammer communications are securely downloaded from Yammer servers.

Yammer content is captured in near-real time and delivered to Global Relay Archive via SMTP, where it is available for compliance review, supervision, or even mobile access.

Supported Yammer content includes: Updates, Replies, Files, Polls, Praises, Questions, Events, Announcements, Private Messages, Group Communications, and Chats.
